## Little not backing down in fight against tax-funded abortion

ALBERTON — An Alberton man, who has said he is prepared to go to jail rather than pay one cent towards tax-funded abortion, believes he has moved a step closer to having his case heard in the Supreme Court of Canada. David Little doesn't deny that he hasn't filed income tax returns. He argues Section 2a of the Charter of Rights and Freedoms, freedom of religion and conscience, gives him the right to refuse.

"I have a sincere and conscientious belief in my faith. That triggers 2a," he argues.

Little says he is not refusing to file simply to get out of paying income taxes.

He was convicted in a New Brunswick courtroom in 2007 on a charge of failing to file income tax returns for 2000, 2001 and 2002. His appeal to the Court of Queens Bench in New Brunswick was rejected last year.

He subsequently appealed to the New Brunswick Court of Appeal. On April 29 the three justices reserved decision on his appeal and Little is calling it a victory of sorts. He expects it will take them three to four months to render a decision.

He plans to use that time to pray that the judges will make a courageous decision.

"I feel we are going to win the case," Little said.
